The title of the articles should be typed in capitals at the top of the article. Generally articles should be no longer than about 300 words. The number of paragraphs should be kept to a minimum. The first word of each paragraph should be indented 5 spaces. If pictures are submitted with the article, the caption should appear on the back. Black and white photos will reproduce best, although color can be reproduced.
