# Alumni Board Report

# Sanders: Scholar & Athlete

"Mental toughness"--probably the best words to describe Brother Kent Sanders, '80.

Kent is one of five Kansas Gamma Sig Ep brothers entering the University of Kansas School of Law next fall, but the work it took for him to get there is somewhat unique.

Although he has a vascular disorder which has caused him to suffer painful headaches, and threatened his life at one time, he has been an active brother to say the least.

As with anyone admitted to law school, Kent's grades are well above average. Kent maintains a 3.4 grade point average--no problem for the Honor Initiate of his 1979 pledge class, right? There's more . . .

Kent has kept his grades up even while competing as captain of the KU soccer team. The team is on "club" status at KU--a far cry from the plush hotels and travel arrangements of

the world of most varsity sports. As captain of the team, Kent has had to play the role of coach, player, and administrator, which means getting the team into tournaments and getting everyone there.

Kent led the soccer team to the number two spot in the Big-8 for the 1980 season.

Kent went to Annonndale High School just outside of Washington D.C., an area he describes as "soccer crazy."

Kent's parents now live in Saudi Arabia--not exactly convenient for weekend visits. His father is employed by Poole International Oil Company of Saudi Arabia.

Kent has made a home away from home at Kansas Gamma, however, and said he has "thoroughly enjoyed" his experience in the house.

"The house can be considered an education in itself," Kent said.

He referred specifically to the Sig Ep College Quiz Bowl team

# Alumni Spotlight . . .

One of the men most instrumental in re-igniting Sigma Phi Epsilon at KU after World War II was Brother Jean Thomas Fisher, '47.

Brother Fisher pledged the house in January, 1941, and went into the Army December, 1942. The war caused the house to disband after the spring semester of 1943.

"Every man in that house volunteered and went," Fisher said. "Except for Harry Hughes, he had a 4-F rating," (physical exemption).

Fisher, stationed at Fort Benning, Georgia, started a newsletter that kept the fraternity alive, and the brothers in contact with one another.

"We took advantage of that free franking (postage) we had in the service. I started out with just a few names, but it grew as I found out where men were. Guys would send me information about other men all the time," Fisher said.

The house in West Hills had been lost, and the lease on Ohio had lapsed, so Kansas Gamma Sigma Phi Epsilon was going to need a chapter house when they returned from the war. Therefore, the big effort was to raise money.

Clarence Freark, the first travelling secretary for Sigma Phi Epsilon, had an office in Lawrence National Bank Building, so donations were sent to Freark in Lawrence during the war, according to Fisher.

"We raised \$15,000 by mail during the war," Fisher said. "That was really the money that got the fraternity started again after the war."

In January, 1946, Kansas Gamma was back open for business at KU, "upstairs over an old pool hall" in the 700 block of Massachusetts Street, according to Fisher.

"I had more fun there than any time of my life," said Fisher.

"God we drank a lot of beer."

He said that everybody was on the G.I.-Bill, so nobody had to work through school.

Before Jean graduated in 1947, the fraternity moved to 1408 Tennessee. That house had been purchased with money raised during the war, and a little help from a man named "Mr. Berlin" from Ottawa who put up a loan.

The parents also helped in the effort to raise funds, Fisher said.

"God we got a lot of money out of those parents. We had a very strong parents organization, it was headed by George Akright," Fisher said.

"George did as much as anybody for that chapter."

That first year back on campus, Sigma Phi Epsilon pledged 50 men.

"The most rewarding time was on Tennessee when we pledged those 50 people--they were pretty damn good people too," Fisher said.

"We had a lot of athletes in the house back in those days," Fisher said. "I think it was 1936 that five of the starting football team were Sig Eps, and we've had all five from the basketball team before too."

During Fisher's days at KU, he lived in the Sig Ep house at four different addresses, starting in West Hills (currently the Delta Gamma sorority house), and ending up at 1408 Tennessee.

The chapter was not long to stay, however. With the 50 pledges that Fisher talked of, the chapter's manpower was at 80. They had two annexes when they started construction at 1645 Tennessee, the current structure.

The chapter had sold the house at 1408 Tennessee, and had to spend one semester in the basement of the Community Building while the new house was being completed. That made six moves in as many years, excluding the war years.

Fisher admitted that it took a lot of work from some of the people to keep the fraternity going, but he's never complained.

"I think those of us that had to work and struggle got a hell of a lot more out of the fraternity than anyone before or since," Fisher said.

Jean Fisher's Sig Ep spirit has wained very little since those days he calls "the best."



He came from a family that is probably the most completely Sig Ep of any in the fraternity's history. His father was an honorary member, his mother was a house mother at KU for a while, and all three brothers are on the Sig Ep roll books.

After graduation, Fisher served a short time as a traveling secretary for Sigma Phi Epsilon.

Since then, he has always been active in the Kansas City Area Alumni Association, and since 1974, the president of the James Naismith Peachbasket Award Committee.

The Peachbasket Award, the brain-child of Brother Fisher, has grown to be the nation's coveted award for outstanding achievement in the sport of basketball. The award is given in honor of Dr. James Naismith, the inventor of basketball, and the first chapter counselor for his fraternity at KU, Sigma Phi Epsilon.

"This year's banquet will be the best ever," Fisher said.

It is scheduled for Tuesday, September 9, in the International Room of the Alameda Plaza Hotel in Kansas City. Oscar Robinson, Cincinnati will be receiving the 1980 award.

In everything he does, Jean Thomas Fisher is the living example of "once a Sig Ep, forever a Sig Ep."

"The fraternity has been very good to me. I've put in a lot of time, but I tell you, it's been a marvelous thing."

## *Jean Fisher, In memoriam*

Brother Jean Thomas Fisher, '47 died June 9 while on a business trip in Hamilton, Bermuda. He was 56.

Brother Fisher was the chief executive officer of the Fisher & Associates Money Management Group of Kansas City. He lived at 4804 W. 83rd in Prairie Village, Ks.

Fisher was president of the Dr. James Naismith Peachbasket Awards Committee, which annually honors an outstanding individual in basketball. He was a member of the Directors Club of the Williams Educational Fund for athletics at the University of Kansas and was a charter member of the Committee of the 101 professional football awards program in Kansas City.

He was associated with the life insurance

industry for 30 years and was a member of the International Association of Financial Planners. He was a member of St. Ann's Catholic Church and the Indian Hills Country Club. He was born in Topeka and had lived in Prairie Village 27 years.

He leaves his wife, Patricia Fisher of the home, a son, two daughters, two brothers and two grandchildren.

The Kansas Gamma Alumni Board contributed \$50 to the Kansas Gamma scholarship fund in memory of Brother Fisher.
