Mother Peters Passes Away

One of the most popular Sig Ep housemothers ever, Marjorie Peters, died November 17, 1979 after an extended illness. She was 67.

"Mom Marge" served as housemother from 1967 to 1975. She held her position during some of the most turbulent years in recent American history. It was a time of campus dissent and difficult times for most fraternities. Her combination of character traits made Mom Marge highly respected and loved by the Chapter. She was a large factor in the Chapter's ability to remain strong during those years.

Born and raised in Holton, Kansas, Marjorie Sinning Peters graduated from KU and spent the next 30 years working with the Treasury Department in Washington, D.C., during which period she met and married her husband and raised a son. After the death of her husband and her retirement from Government service she returned to Kansas. She quickly tired of the "easy" life of retirement and applied for a position as a fraternity housemother at KU. She was quickly hired by SPE and was thereafter known to over 200 young men from 1967 to 1975 as "Mother Marge."

Mother Marge was always accessible. Her door was always open. She was a loyal, kind woman who was always willing to listen and to offer guidance, but only when it was requested. was tolerant. I guess you couldn't live in that house for eight years and see and hear what there was to see and hear without being tolerant! She truly enjoyed the house; she enjoyed being with "her boys." She enjoyed the parties and Chapter functions, the serious work

She loved the challenge we gave her. We meant a great deal to her. This was exemplified by the fact that she was buried wearing a Sig Ep pin.



Brother Steve Graves, one of the premier swimmers in the Big Eight conference, returned to KU this fall after a summer of workouts on the West Coast. With the workouts behind, the Wichita junior is already thinking ahead to the NCAA swimming and diving championships this spring.

Brother Graves set three records during last season's Big Eight conference meet. He also competed in the NCAA championships last season. "I've never placed in the nationals," Graves said. "I'm capable, but things didn't go down right. I hope to change that around this season."

Graves spent this past summer swimming for the Dutch Boys, an AAU club in Los Angeles. The highly competitive Dutch Boys placed fourth in the nation in AAU competition. 'I gained a lot of experience swimming with the Dutch Boys," Brother Graves said. "They're the top swim club in the West and everyone who's any good comes out to compete on a national level with other clubs."

Bill Spahn, KU swimming coach, has big plans for Graves, who will swim the 100 and 200 breaststroke and individual medleys for the Jayhawks this season. "I'd like to see him place in the nationals," Spahn said. "He's been working toward that very hard and we'll be expecting good things from him this season. He's one of the best."

Graves said he also would like to see the team place in NCAA competition this season. "I want the team to win the Big Eight and the NCAA," Graves said. "Nearly everyone is back and our recruits should make up for some of our losses."

Even with all his summer workouts behind him, Brother Graves is still working out on his own to improve his style. "I could always stand some improvement in my stroke and overall strength," Graves said. "The stronger you are, the faster you swim, so I've been working out with weights."

There will be plenty of Sig Eps at Robinson Natatorium throughout the season to cheer Brothers Graves on to another great year.

- Purchased a new water softener:
- Allocated funds to redecorate the president's room;
- Accepted a new upright freezer from the Dad's Club:
- Contracted to have an improved fire alarm system installed in the Chapter house;
- Approved a contrib-

ution to the Mother Marge Peters Scholarship Pund;

- Authorized the establishment of a "Building Committee" to research, study and report back to the Board the feasibility in housing improvements necessary during the next five years. The three primary options being reviewed by this committee are: a.) Major renovations to the current house structure: b.) Constructing a new chapter house on the current property; c.) Buying available property and building a new Chapter house: and
- Study the possibility of annexing apartments for leasing to Chapter members.

The financial position of the Board is very good. The liabilities of the Alumni Board are based primarily on two notes. A 1964 secured note, at six percent with Capitol Federal, requires a \$440 monthly payment through August, 1984. A 1977 note for house remodeling provides for monthly payments of \$525 to University State Bank until 1983.

KARL KRUEGER died in July, 1979 at age 85. Krueger was responsible for convincing Kansas City civic leaders to create a philharmonic. He was the conductor of the Kansas City Philharmonic for its first ten years. Krueger also was conductor for the Seattle Symphony and Detroit Symphony. Krueger founded an orchestra in New York to perform American art music. He wrote a historical survey of his profession, The Art of the Conductor. Krueger also founded the Society for the Preservation of American Musical Heritage.

The Kansas City Star's music editor stated upon Krueger's death:

> Krueger was a man of many interests and achievements. but for many Kansas Citians, his most important legacy is the Philharmonic. As the orchestra enters its 47th season, it is stimulating to recall the vision that created it and the aura of adventure that surrounded its early years. For these and many others, Karl Krueger will long be remembered.
